1. Diploma in Rubber Technology (DRE)

Eligibility: 12th passed with science or working experience in rubber industries for arts/commerce subject.

Course duration: 12 months

Course fee: ₹ 41750/- or in two equal EMI in six months

2. PG Diploma in Rubber Technology (PGDRE)

Eligibility: 12th/DRT passed

Course duration: 12 months

Course fee: ₹ 46750/- or in two equal EMI in six months

Beneficiary: For the experienced individuals.

3. B.Sc in Polymer Science

Eligibility: 12th passed with Physics, Chemistry and Mathematics

Course duration: 36 months

Course fee: ₹ 117750/- (Every year ₹ 39250/- or in two equal EMI in six months)

4. M.Sc in Polymer Science

Eligibility: B.Sc with Polymer Science/Chemistry

Course duration: 24 months

Course fee: ₹ 102750/- (Every year ₹ 51375/- or in two equal EMI in six months)

5. B.Tech in Polymer Engineering
